This is your opportunity to share your knowledge and expertise with NAEN Members from both Canada and the United States.

In crafting your proposal, please keep in mind that The **North American Association of Educational Negotiators (NAEN)** is a network of educational management experts for effective employee relations. NAEN members are management negotiators in K-12 school districts, community colleges, and universities. We focus not only on collective bargaining, but human resources, community relations, labor management, and contract interpretation and administration.

Program submissions should be substantive with key principles, practices, and programming elements which can easily be adapted. Avoid heavy theoretical components and ambiguity in your proposal. Finally, this is a **60-minute presentation** which includes question and answer, so be realistic as to how much you can cover. **Proposals may include one or two presenters, or may be presented**

**as a panel. Presentations may be specific to Canada or the United States, or both. Please indicate accordingly, as a balance of jurisdictional topics is preferred.**

- Your topic is consistent with the mission of NAEN
- You complete the submission process by August 1, 2018 (Note: you may edit during the submission period of November 1, 2018 to February 15, 2019)

1. Proposed Session Title - 15 word maximum
2. Proposed Session Description - 40 word maximum.
